**Attendance by Board Members:** *Jud McCarthy, Sy Schulman, Lewis Miller, Angelo Gasparri, Fred Goetz, Emily Santos, Bill Gee, Larry Salerno and Vance Vallandigham.*

**Call for Quorum:** After making welcoming remarks, President *Jud McCarthy* turned the meeting over to the Secretary *Lew Miller*. The Secretary reported that 66 members in good standing were present and that he was also in possession of 67 proxies, thus meeting the quorum requirements. The first annual meeting of the IBM South Florida Quarter Century Club and Alumni Association was called to order at 2:56 p.m.

**Acceptance Previous Annual Meeting Minutes:** This being the first annual meeting of the IBM South Florida Quarter Century Club and Alumni Association, there were no previous minutes and no need to vote.

**Treasurer's Report:** Treasurer *Sy Schulman* reported 2011 expenses of \$2,530 and estimated 2012 expenses of \$6,100 including repayment of Founders' loans of \$1,750. The closing cash balance as of December 31, 2011 is estimated to be \$9,500 after payment of expenses associated with the annual meeting. Motion by *Pete Sheridan*, seconded by *Vance Vallandigham*, to accept the Treasurer's report as submitted was passed unanimously.

Subsequent discussion from the members during a Q&A session yielded a number of suggestions for improving communication with potential new members and two volunteers for the Marketing Committee.

The Board wishes to recognize *Julie Goodwin, Bill Gee* and *Dave Johnson* for their significant contributions to the efficient functioning of the Association's operations during 2011.

There being no further business to conduct, *Dave Johnson* moved to adjourn the meeting, seconded by *Emily Santos* and passed unanimously. The meeting was adjourned at 3:18 p.m.

The new Board will hold an organizational meeting prior to the end of the year at a location to be determined. The next regular Board meeting was scheduled for Wednesday, January 11, 2012 at 1:30

## Where are Sue and George King?

*Sue King* took early retirement from IBM in the spring of 1992. She went to work at Apple Computer, Inc. in Cupertino, CA, from mid 1992 to fall 1993 as Director of Future Technologies for Powerbooks and later in Newton Development. *George* followed in the summer of 1992 and worked at CIC, a language technology company.



In October 1993, *Sue* moved to Dell Computer Corp. and worked there from fall 1993 to summer 1996 as Director in charge of Systems Software Development, Contracts and Preload Manufacturing as well as Publications and later as Director of Server and Network Software.

*George* worked at Dell in charge of Peripheral Qualification and Test. *Sue* was stricken with breast cancer in fall 1995, which she has so far managed to overcome (RAH!) with *George's* loving care and the help of a wonderful team of doctors.

In summer 1996, *Sue and George* moved back to CA where *Sue* went to work for Cadence Design Systems, first as VP of Customer Support and Publications, later adding worldwide Consulting Services. *George* took charge of restoring the 1912 Arts and Crafts farmhouse and landscaping the 1/2 acre property. His excellent work earned a spot in the annual Willow Glen Home Tour.

In 2000, *Sue* retired to care for her mother. She did some consulting with US, Russian and Asian universities primarily in developing training for young engineers on using Cadence design tools. She also consulted for various CA governmental agencies on future strategies (obviously that hasn't

gone too well! You can only lead the horses to water, you can't make them drink!). *Sue* fully retired in 2004.

*Sue and George* say, "We spent 10 years looking all across the US for the "perfect" place to retire . If you had asked us where we would end up, we would never have said "Nevada". Yet in 2007, we sold our CA home and moved to Gardnerville, NV, a high desert (elev. 4750 ft) area with relatively mild weather, close proximity to Lake Tahoe and its activities and easy shooting distance to San Francisco and surrounding areas. The people here are incredibly friendly and helpful and the cost of living is much reduced. "It took 18 months to find our "perfect" house with glorious views of the Sierras. We added an extra large garage to hold *George's* car collection (now counting eight) and a tractor."

*George* is occupying his time with "moving dirt", and is about to move 20 trees around our 6 acres property and add an orchard. *Sue* has delighted in working with a local art gallery organizing art workshops given by local artists.

The Gardnerville area is filled with many talented artists in many media. *Sue* learned gourd art and relief print-making and has made many new and talented friends. Their children live in Australia, LA and Portland. They and many friends visit frequently.

In closing, *Sue and George* say, "We have effectively turned our home into the King Bed and Breakfast and have lots of fun taking friends and family to visit Yosemite, Mono Lake and Lake Tahoe. To all our old friends, ya'll come!"

### MEET IBM'S NEW PRESIDENT AND CEO: VIRGINIA M. ROMETTY

*Ms. Rometty* began her career with IBM in 1981 in Detroit, Michigan. Since then she has held a series of leadership positions in IBM, most recently as Senior Vice President and Group Executive, IBM Sales, Marketing and Strategy. As IBM's global sales leader, she was accountable for revenue, profit, and client satisfaction in the 170 global markets in which IBM does business. She was responsible for IBM's worldwide results, which exceeded \$99 billion in 2010, and for leading IBM's global strategy, marketing and communications functions. In this role, she established IBM's Growth Markets organization, which is expected to contribute as much as 30 percent of IBM revenues by 2015.

In prior leadership roles, *Ms. Rometty* served as Senior Vice President, IBM Global Business Services where she led the successful integration of PricewaterhouseCoopers Consulting. This acquisition was the largest in professional services history, creating a global team of more than 100,000 business consultants and service experts. For her leadership, she received the 2006 Carl Sloane Award given by the Association of Management Consulting Firms. She has also served as general manager of IBM Global Services, Americas, as well as general manager of IBM's Global Insurance and Financial Services Sector.

*Ms. Rometty* is a leader in diversity initiatives including IBM's Women in Technology Council and the Women's Leadership Council, and is one of the senior sponsors of the Women's Executive Council. She is a frequent speaker at industry and business conferences, and has been named to Fortune magazine's "50 Most Powerful Women in Business" for seven consecutive years, including most recently in 2011.

*Ms. Rometty* serves on the Council on Foreign Relations; the Board of Trustees of Northwestern University; and the Board of Overseers and Board of Managers of Memorial Sloan-Kettering Cancer Center.

She holds a Bachelor of Science degree with high honors in computer science and electrical engineering from Northwestern University.
